

2016 Limited Warranty

e-Systems Group, LLC (the "Manufacturer") warrants that all consoles, technical furniture and enclosure products manufactured by it will be free from defects in materials and workmanship from the date of transfer of ownership as follows:

- (1) LIFETIME WARRANTY on all fixed structural frames and components manufactured by e-Systems Group;
- (2) All fixed exterior panels (steel and laminate) and work surface components for a period of one (1) year;
- (3) All adjustable, sliding, or hinged mechanisms, media storage devices, hardware or components for a period of one (1) year;
- (4) Motorized lift systems (height-adjustable) shall default to supplier's warranty terms; LCD and flat panel arm mounts shall default to supplier's warranty terms.
- (5) All fans, power strips, plugs, outlets, surge suppressors, and lights (excluding light bulbs), latches, locks, shock absorbers, glides, ball bearings, other moving parts, and media packs for a period of one (1) year.
- (6) This warranty does not cover any items that are in one or more of the following categories: electrical systems, software and accessories.
- (7) No warranty coverage on glass components

This warranty and the rights and benefits hereunder apply to the original purchaser of products only and may not be transferred or assigned to any other person without the prior written consent of e-Systems Group.

The effective date of the terms and conditions of this warranty statement applies to products shipped on or after August 1, 2009, from manufacturing locations in Westminster, CO, or Conklin, NY.

Written notice of any claim under this limited warranty shall be delivered to e-Systems Group not later than the expiration of the applicable warranty period (the "Warranty Notice Period"). In the event that a written notice of a claim under this limited warranty is not delivered to e-Systems Group prior to the expiration of the relevant Warranty Notice Period, the manufacturer shall have no obligation to repair or

replace the product and shall have no other liability whatsoever under this limited warranty. During a particular warranty period, e-Systems Group will replace or repair (at its sole discretion) products covered by this limited warranty. Replacements may be made with identical or similar product of a like kind or price at e-Systems Group's sole discretion.

All defective products may be requested for return (upon receiving a return authorization) to e-Systems Group facility, or authorized company supplier, for inspection and manufacturer's disposition. We will ship the repaired or replacement products to the Customer with prepaid freight. This warranty does not cover damage due to external causes, including accident, abuse, misuse, improper application or installation by parties other than e-Systems Group or parties under the control or direction of e-Systems Group.

e-Systems Group will not be responsible for customer alterations, product storage, servicing not authorized by the manufacturer, usage not in accordance with product instructions, negligent use, and failure to properly maintain products. Due to the potential for environmentally induced damage, our products require use in a climate-controlled work environment at all times. In addition, this warranty does not cover any damage due to shipping and handling or the effects of normal wear and tear. The warranty term for any product or component that is replaced or repaired shall be the balance of the remaining warranty term applicable.

IN NO EVENT IS E-SYSTEMS GROUP LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES BY REASON OF ANY BREACH OF WARRANTY OR DEFECT IN MATERIAL OR WORKMANSHIP. E-SYSTEMS GROUP SHALL NOT BE RESPONSIBLE FOR REPAIR OR REPLACEMENT OF ITEMS THAT HAVE BEEN SUBJECTED TO NEGLIGENCE, ACCIDENT OR IMPROPER USE OR WHICH HAVE BEEN ALTERED BY OTHER THAN AUTHORIZED MANUFACTURER PERSONNEL. THIS LIMITED WARRANTY STATEMENT IS THE ENTIRE WARRANTY PROVIDED BY E-SYSTEMS GROUP MAKES NO EXPRESS WARRANTIES OR CONDITIONS BEYOND THOSE STATED IN THIS LIMITED WARRANTY STATEMENT AND THE TERMS OF THIS LIMITED WARRANTY STATEMENT SUPERSEDE ANY OTHER COVENANTS, AGREEMENTS OR UNDERSTANDING WITH RESPECT TO THE SUBJECT MATTER REFERRED TO HEREIN. IN NO EVENT SHALL OUR LIABILITY EXCEED THE PURCHASE PRICE OF THE PRODUCT PURCHASED.
